MUNICIPAL ORDINANCE NO. 2020 - 556

AN ORDINANCE ADOPTING THE OFFICIAL SEAL OF THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF COMPOSTELA, PROVINCE OF DAVAO DE ORO

WHEREAS, under Section 446 of the Local Government Code of 1991, to wit: "The Sangguniang Bayan, the legislative body of the of the municipality, shall be composed of the Municipal Vice Mayor as the Presiding Officer, the regular Sangguniang Bayan members, the president of the Municipal Chapter of the Liga ng Mga Barangay, the president of the Pambayang Pederasyon ng mga Sangguniang Kabataan, and the Sectoral Representatives as members";

WHEREAS, adopting the official seal for the Office of the Sangguniang Bayan serves the purpose of having a concrete symbol of its authority as well as a constant reminder of the duties and responsibilities of its official and employees as defined under the Local Government Code, other laws, rules and regulations affecting local governance and public service;

NOW THEREFORE:


Be it ordained by the Sangguniang Bayan of Compostela, Davao de Oro in session assembled that:

SECTION 1. TITLE. This ordinance shall be known as "OFFICIAL SEAL OF THE SANGGUNIANG BAYAN OF COMPOSTELA, PROVINCE OF DAVAO DE ORO"

SECTION 2. THE OFFICIAL SEAL



SECTION 3. SYMBOLISM. The Official Seal of the Sangguniang Bayan of Compostela, Davao de Oro shows the images and meaning, to wit:

A. THE CIRCLE OUTLINE:

- Represents oneness and unity of the people of Compostela.
- The Circle is drawn in a rope figure where every strand reflects an individual co-existing in harmony with one another.

B. THE ABSTRACT HUMAN FIGURE

- The 11 abstract human figures drawn in a circular form with equal sizes and with the same color represent the honorable members of the august body.
- Illustrated with equal size to reflect equality, fairness and equal rights and privileges as legislators.
- It is formed in a circular manner to show singularity of purpose.
- Drawn in white color to elucidate purity and goodness of the institution.

C. THE OUTLINE OF THE SEAL

• The outline of the logo at the center symbolizes the Sangguniang Bayan's commitment to serve and protect the people of the Municipality of Compostela, Davao de Oro.

D. THE DOVE WITH A LAUREL IN ITS BEAK

- The dove illustrated above the center of the seal symbolizes the Guidance of the Almighty to the Sangguniang Bayan.
- The laurel depicts recognition of honor and achievement of the Sanggunian.

E. THE STRUCTURE OF A LEGISLATIVE BUIDLING WITH A FLAG

- Reflects the Sangguniang Bayan edifice.
- The triangular shape of the structure elucidates peace, justice and equality as guiding principles of the Saggunian.

F. THE SIXTEEN (16) SUN RAYS

• The sixteen (16) sun rays represent the 16 barangays that comprise the Municipality of Compostela.

G. THE SCROLL WITH A QUILL

• Representation of the Councilor's Creed to enact measures and ordinances as legislators mandate for the general welfare of the people.

 It symbolizes an official document be it an ordinance or a measure enacted by the Sangguniang Bayan.

H. THE GAVEL

- The object reflects the mallet used by the Presiding Officer to command attention and confirm action.
- It represents the presiding officer's entity in spearheading the institution.
- Symbolizes the figure of the Vice Mayor.

THE USE OF COLORS

GOLD - wisdom, courage, passion
BLUE - depth and stability

WHITE - positive connotation, purity
BROWN - steadfastness and dependability

SECTION 4. OFFICIAL USE. Only the Office of the Sangguniang Bayan of Compostela, Davao de Oro and its local officials and employees shall use the official seal:

- A. To authenticate all resolutions, ordinances, public documents and administrative issuances;
- B. As letterhead in official communication and correspondence in the exercise of the Sanggunian's legislative and other functions;
- C. To be affixed upon such other official documents, plates and papers of the Office of the Sangguniang Bayan of Compostela, Davao de Oro;
- D. To be affixed as a symbol of the Sanggunian in all its affairs within or outside the municipality; and
- E. To be affixed upon Sanggunian pins, service rings, stickers or be embroidered and affixed upon the uniforms of Sanggunian officials and employees.

SECTION 5. PERMANENT DISPLAY OF CARVED OFFICIAL SEAL. As a sign of authority there shall be made a carved official seals of the Sangguniang Bayan of the Municipality of Compostela either in wood, stone, brass, clay or other medium. They shall be permanently attached/displayed at the Sangguniang Bayan Session Hall.

SECTION 6. THE DRY SEAL. There shall be a dry seal in authenticating public documents or administrative issuances and the Secretary to the Sanggunian shall have custody and care of the dry seal that shall be kept and secured inside the office after office hours.

SECTION 4. EFFECTIVITY CLAUSE. This ordinance shall take effect upon approval of the Local Chief Executive.
